## SPECIAL AND CHARTER TRAIN COACHING STOCK

#### A) RIVIERA TRAINS

The company has now leased a further seven vehicles from HSBC Rail (UK) bringing the total now leased to twenty. The additional vehicles are Mark 2F RFBs 1200, 1203 & 1258, Mark 2E FO 3229, Mark 2E TSO 5791, Mark 2F BSO 9526 and BG(NE) 92175. Of these 1200, 1203, 5791 and 9526 are now based at Old Oak Common with the remainder at Crewe. 1200 has already been repainted into the companies Oxford Blue and Cream livery.

Other developments are the purchase of Mark 2A TSO 5345 from HSBC Rail (UK), this is now stored at Crewe Carriage Shed awaiting mechanical attention before returning to use. Mark 2D TSOs 5630 and 5732 have been taken out of service and are now stored at Crewe Carriage Shed.

Four Mark 1 FOs, latterly part of the Crewe based 'Northern Belle' operation have been purchased from Venice-Simplon Orient Express, these are 3066, 3068, 3069 and 3125. All four are based at Crewe and carry Oxford Blue & Cream livery but it is intended that they will soon be repainted into Brunswick Green and Cream livery, this livery already being carried by BFK 17079. Also due to be painted into Brunswick Green & Cream livery are several Mark 2A TSOs and Mark 1 RBR 1651 currently undergoing overhaul at Cranmore. Together these carriages will form Crewe based CP02 set.
