SPECIAL AND CHARTER TRAIN COACHING STOCK

A) VINTAGE TRAINS

In light of the Mark 1 rolling stock provisions in the Railway Safety Regulations 1999 it is considered extremely unlikely that any of the nine Pullman Cars; Kitchen Second CAR No.335, Parlour Seconds CAR No.347, CAR No.348, CAR No.349, CAR No.350, CAR No.351, CAR No.352, CAR No.353 and Bar Car HADRIAN BAR will ever operate on the Network Rail network. Thus they are now considered to be preserved, CAR No.349 remains located at the Kent & East Sussex Railway, whilst the remainder are located at Tyseley Locomotive Works, Birmingham.

B) FLYING SCOTSMAN RAILWAYS

In light of the Mark 1 rolling stock provisions in the Railway Safety Regulations 1999 it is considered extremely unlikely that any of the four Pullman Cars, Kitchen Firsts HERON, SWIFT, Parlour First AMETHYST and Kitchen Second CAR No.337 will ever operate on the Network Rail network. Thus they are now considered to be preserved, HERON remains at the Great Central Railway, SWIFT and CAR No.337 at Steamtown Railway Centre, Carnforth and AMETHYST at Southall. Similarly it is considered extremely unlikely that Mark 1 SLF 2013 will ever operate on the Network Rail network and this is also now considered to be preserved.

The North Yorkshire Moors Railway has not applied for exemption from the Mark 1 rolling stock provisions in the Railway Safety Regulations 1999. Thus its set of eight carriages, three Pullman Cars and eight Mark 1s, is no longer permitted to venture beyond Grosmont with fare-paying passengers. These vehicles received vehicle acceptance in 1998 for use between Grosmont and Whitby only. Apart from a very limited number of outings after vehicle acceptance was granted they have seen no further use on the Network Rail network.
