Amendment Sheets – the future

Following a couple of years' consideration I have come to a decision regarding the future of these sheets. For the foreseeable future at least, they are to continue as at present, being made available for the mutual benefit of those with an interest in preserved carriages. Also to remain available on request are the listings of 'Preserved Coaching Stock of British Railways part one – BR Design Stock' and 'Preserved Coaching Stock of British Railways part two – Grouping Design Stock' (see Amendment sheets 94 and 99 for further details). The latter is progressively having certain later pre-grouping carriages added as research progresses.

I am though aware that I have not heard from a number of recipients of the sheets for some time and although I presume that you all still have a passion for preserved carriages that may no longer be the case. Thus, in order to continue to receive these sheets, I ask all current recipients to make contact confirming that they wish to continue to receive the sheets and by which method (email attachment (preferred) or Royal Mail letter). If any current recipients do not make contact then this will be the last 'Amendment Sheet' they receive from me.

One of the reasons for continuing has been messages of appreciation received for creating a historical resource for those interested in the preservation history of carriages. The availability of sheets in electronic format having made searching for references to an individual carriage much easier. Thus, if any recipients require back numbers of 'Amendment Sheets' in electronic format then these can be provided. As many of you will know, during 2010 I have trialled making the information from the sheets available through the RCTS. This has not proved successful but it is still possible that all 'Amendment Sheets' may be made available through the RCTS website at a future date.

Finally, I would like to thank all those who regularly pass on snippets of information regarding preserved carriages to me for inclusion on the 'Amendment Sheets'. If it was not for you the 'Mysterious Carriages' section on these sheets would take up a lot more space than it does!
