GWR FRUIT D 2336 (024239) and GWR WATER TANK WAGON 106 (DW106 - ADW106)

These two vehicles were located at Titley Junction Station, near Kington, Herefordshire. It is understood they departed c2014, yet despite extensive enquiries it has not been possible to establish precisely when they left and to where they went. Does anyone have any information that might help solve this mystery?

BR Mark I BCK 21240 This carriage remained at the former premises of D C Engineering & Restorations at Shildon when the company relocated to Spennymoor, as the company no longer had an involvement with it. On 17th February 2021 it departed by road from Shildon but it has not been possible to establish to where it went. Does anyone have any information that might help establish the current whereabouts of this carriage?
